The 27 July 2019 Detachment of Minnesota Executive Committee Conference Call was called to order by Detachment Commander David A Vulcan at 10:00am. The following were on the conference call: David A Vulcan, Dennis J Henkemeyer, PNC Douglas Bible, PNC Joe Mayne, Shawn Davis, Gary Weaver, Tim Weaver, Robert Foss, Larry Ripplinger, Daryl Harmon, John Weiss, Bill Goede, Robert Bristo, Walter Folendorf and Casey Lenort. Special guest Department Commander Mark Dvorak was also on the call.

After a welcome by Commander Vulcan, he turned the meeting over to Detachment Membership Director Robert Foss who talked about the goals for the 2020 membership year. Foss talked about the various cash payouts for different categories. He also talked about “Bolting for Membership” and the goal of reaching 100% this coming year. Discussion followed. PNC Mayne asked if we would be prepping squadrons and districts about the national dues increase. Tim Weaver suggested a cash incentive for the highest percentage over previous year.

Media and Communications

PNC Mayne discussed the objectives of the media and communications goals for the upcoming year. He reviewed the report that had been prepared and distributed.

Legislation

Chairman John Weiss talked about better communications between The American Legion and the Sons of The American Legion. John was reminded that the department will have a new legislative chairman for the coming year and it was suggested that he reach out to that person

after 03 August when Commander Dvorak announces his selection of appointments.

Internal Affairs

PNC Mayne talked about he “Legionnaire of the Year” award. He has three or four nominees and suggested that maybe a small committee could be formed from the delegates at the national convention for the purpose of selecting a winner.

As for finance, he felt that Finance Committee Chairman Blue could review and recommend planned giving and also address the national dues increase.

Legionville

Detachment Adjutant Henkemeyer talked about an email that he received from President Gilbertson the day before regarding the need to replace a water heater and the cost of \$9,000.00. After much discussion, a motion was made by John Weiss to recommend to the finance committee that we donate \$2,000.00 to Legionville to help defray the cost of the water heater. The motion was seconded by Shawn Davis. PNC Bible suggested that a letter be sent to all the squadrons and districts requesting that they consider donations. It was recommended that all donations be sent directly to Commander Vulcan. Adjutant Henkemeyer stated that the minutes from the detachment convention will be sent out on 05 August and a letter will be included as well. The question was called and the motion carried.

Special Guest

Commander Vulcan then asked Department Commander Dvorak to address the conference call. Commander Dvorak told everyone that he is proud to be a dual member and looks forward to working closely with the SAL during the coming year. He acknowledged all the good things that the SAL does and encouraged everyone to keep up the good work. The commander also commented on the well run and informative conference call.

Closing

Commander Vulcan again thanked everyone for being on the conference call. He stated that his project this year is twofold. One third of the donations will go to the John Zgoda Memorial Deer Hunt for Disabled Veterans and two thirds will go to Legionville. In keeping with the national theme for the coming year, the official Minnesota logo will be a lightning bolt.

A motion was made by Tim Weaver, it was seconded by Bill Goede and the conference call was adjourned at 10:41am.
